INTRODUCTION

The Deer Creek - Mackinaw Education Foundation (DCMEF) announces the establishment of a scholarship to be awarded annually to two (2) college or university freshmen, one male and one female, who have graduated from Deer Creek - Mackinaw High School.

AWARD

The DCMEF will award two (2) \$1,000 scholarships, one each, to a male and a female candidate enrolled as a freshman in an accredited two year or four year college or university. The award will be made directly to the college or university by the fall semester of the chosen candidates' freshman year.

APPLICATION REQUIREMENTS

1. Completed DCMEF Scholarship Application Form, including the signed release allowing the Foundation Board of Directors to review your high school academic records.
2. Submission of an essay. The essay should provide insight to the Foundation Board of Directors into the candidates' character, strengths and educational goals as well as addressing the candidate's growth during their high school career. Further the essay should be typed; double spaced, and not exceed 1000 words in length.
3. Two letters of recommendation from either instructors, employers or any other significant adult in your life, with the exception of family members.

APPLICATION DEADLINE

Applications should be submitted to DCMEF in the year of candidate's graduation from Deer Creek - Mackinaw High School. All application materials must be received no later than April 1st and must be mailed to the Deer Creek - Mackinaw Education Foundation, P.O. Box 621, Mackinaw, IL 61755.

CRITERIA

This scholarship is awarded based on growth over the candidate's 4 years at Dee-Mack High School. Therefore, the successful candidates will be determined by meeting the following criteria:

- Academic Growth across the candidate's high school career as measured by Grade Point Average (GPA), PSAT 8/9, PSAT/NMSQT, PSAT 10, and SAT assessment scores or progress monitoring testing, and class ranking;
- Application/Essay Submission detailing the candidate's growth in high school; and,
- Attendance and Punctuality across the candidates' high school career (Note: medical conditions negatively impacting attendance will be taken under consideration).

In order to assess the candidate's growth, the data outlined above, must accompany the application to the Board of Directors. Failure to do so, will be considered an incomplete application.
